#### MEMORANDUM OF UNDERSTANDING Between The STATE OF ALASKA DEPARTMENT OF FISH AND GAME HABITAT DIVISION And The USDA, FOREST SERVICE ALASKA REGION

This MEMORANDUM OF UNDERSTANDING (MOU) is hereby made and entered into by and between the State of Alaska, Department of Fish and Game, hereinafter referred to as "Department," and the USDA, Forest Service, Alaska Region, hereinafter referred to as the "U.S. Forest Service."

Title: Alaska Fish Protection

**PURPOSE:** The purpose of this MOU is to document the cooperation between the parties to provide a process for the Forest Service and the Department to cooperatively protect fish resources and habitats on National Forests in Alaska in accordance with the following provisions.

#### THE FOREST SERVICE AND THE DEPARTMENT MUTUALLY AGREE TO:

- ✓ Respect the authorities and expertise of each agency to protect fish habitat and ensure fish passage.
- ✓ Reach agreement per a written concurrence prior to instream activity.
- ✓ Resolve disputes at the field level by
  - o clarifying mutual interests and points of agreement,
  - o visiting the project together to discuss and reconcile site-specific issues,
  - consulting experienced staff to help reconcile differences of opinion and interpretation.
- Elevate disputes not resolved at the field level to the District Ranger and Habitat Division Regional Supervisor or Area Manger in the form of a briefing paper, jointly prepared by involved field staff, including a project summary and background, steps taken by field staff to resolve the dispute, unresolved issues, and recommendations and rationale for solutions. Unresolved disputes will advance to the Forest Supervisor and the Division of Habitat Director, and finally,

Mutual Interests: ... the Forest Service and the Department's Division of Habitat agree that maintaining an open dialog, sharing data, and working collaboratively during project development, implementation, and monitoring is essential for continued protection of the fish resources of the Tongass and Chugach National Forests.

Purpose: ...provide a process for the Forest Service and the Department to cooperatively protect fish resources and habitat...

### Mutually agree to:

- Respect the authorities and expertise of each agency to protect fish habitat and ensure fish passage.
- Resolve disputes at the field level.

### The Department Shall:

- Review concurrence request and notify the Forest Service within 7 days if additional information is needed.
- Provide a written response of concurrence within 30 days of request.
- Regularly participate in project construction and monitoring inspections. Annually participate in Forest Service best management practices monitoring field visits. Participate in Forest Service watershed restoration monitoring workshops.
- Develop General Concurrences for routine activities.

### The Forest Service Shall:

- Seek involvement during instream activity and planning.
- ...request concurrence at least 30 days prior to instream activity...
- Include all concurrence provisions in the contract award...
- Assist with Catalog of Waters Important for Spawning, Rearing, or Migration of Anadromous Fishes updates.

The MOU includes all sorts of important Federally required legalese such as:

Dear Mr. Martin:

Pursuant to AS 16.05.841 and AS 16.05.871(b), the Alaska Department of Fish and Game (ADF&G) Division of Habitat has reviewed your proposal to reconstruct and maintain Tongass National Forest infrastructure.

#### **Project Description**

You will reconstruct and maintain previously authorized fish passes. You will remove or replace previously authorized stream crossing structures using stream simulation design (Appendix A).<sup>1</sup> You will maintain previously authorized roads at stream crossings. When completing these activities, you will employ best management practices to control sedimentation and erosion. You will schedule work according to the timing table for in-stream construction to minimize impacts to fish and fish passage (Appendix B).

#### USDA Forest Service Agreement No. 14-MU-11100100-015

In accordance with the fish passage act at AS 16.05.841 and the anadromous fish act at AS 16.05.871(d), this is our concurrence for reconstruction and maintenance of previously authorized Tongass National Forest structures.
